- **SUMMARY:** I have been dealing with the national conflicts in ex-Yugoslavia. I have especially focused on Serbian and Croatian nationalisms and the idea and ideologies of Yugoslavism before the WWI, during the War, and between the two World Wars. Foreign press writing on dissolution of the Socialist Yugoslavia and the Wars of Its Succession has also been in the focus of my attention. In the context, the stereotypes of the Balkans, and particularly of the Serbs, have always been a very important subject of my interest. I defended the Ph.D. thesis *Shifts in the Interpretations of the Death of Yugoslavia*. To sum up, I am deeply interested in political sociology and sociology of knowledge, different ideologies, ex-Yugoslavia, and its successor states, theories of ethnicity, nation and nationalism, national minorities, refugees, conflict and war studies.
