My areas of specialization are Philosophy of Psychology, Cognitive Science, Philosophy of Biology, and Philosophy of Education. My main interest lies in bringing relevant results of psychological research to bear on long-standing philosophical problems and bringing important philosophical insights to bear on ongoing psychological research. In my work so far I have focused on the development of human psychological capacities and have tried to shed light on the ongoing debates related to the role of experiential versus biological factors in that development. Currently, my research focuses on the relationship between developmental psychology, on hand, and moral theory and philosophy of science, on the other, as I believe that the insights gained in developmental research could help us understand better the nature of scientific practice as well as moral theory.
